



## AACE-I Meeting March 27, 2008 (Thursday) North Augusta Community Center 495 Brookside Drive North Augusta, SC

Fred Humes is a native of Charleston, South Carolina where he attended public school graduating from Chicora High School in 1958. He attended and graduated from North Greenville Junior College. Mr. Humes later graduated from the University of Tennessee with a Bachelor of Science degree in Business Administration and later received a Master of Science degree from Troy State University.

Mr. Humes enlisted in the United States Air Force in 1962. He became a commissioned officer in 1965. He entered the USAF Pilot Training program three years later and received his pilot wings in 1969. After advanced pilot training, Fred served 13 months in Vietnam and returned to the United States as a Flight Instructor. Mr. Humes flying career included the F-4, OV-10, T-39 and C-141 aircraft as a line pilot, instructor and flight examiner. He served in various capacities at Major Air Command Headquarters, US Air Force Headquarters, and at Pentagon staff and operational assignments. Mr. Humes graduated from the Air Command and Staff College. He completed his Air Force career in 1983 after a four-year staff tour at the Pentagon.

Mr. Humes began a second career with a nationally syndicated television show in Aiken, South Carolina and in 1987 co-founded a video production company where he was President until 1990, when he joined the Economic Development Partnership. The Partnership represents the economic development interests of Aiken and Edgefield Counties. Since joining the Partnership over \$5.0 Billion dollars and 11,000 jobs have been announced in Aiken and Edgefield Counties. Mr. Humes has been recognized twice as the "Economic Development Practitioner of the Year" by Southern Business and Development Magazine. He was selected in 2003 as one of the Top Ten Economic Developers of the Decade by the same magazine. Mr. Humes chaired the Cluster Activation Task Force for the South Carolina Council on Competitiveness. Fred is a past member of the Board of Directors and Past President of the South Carolina Economic Developers Association (SCEDA) and Past Director of the Southern Economic Development Council (SEDC). He is a member of several civic organizations and is Past President of the North Augusta Rotary Club. Mr. Humes is Chairman of the Board of Directors of the South Carolina Hydrogen and Fuel Cell Alliance. He currently serves as a member of the Board of Directors of the Savannah River Regional Diversification Initiative, the Savannah River Site Redevelopment Authority, the Aiken County School to Work Consortium and various other organizations. Mr. Humes is a Certified Economic Developer by the State of South Carolina.

Fred and his wife Barbara have two children and three grandchildren

## 2/28/08 Dinner Meeting The Future of North Augusta, Planning and Managing for Success Mayor Lark Jones

The February Meeting for the CSRA Section was held at the North Augusta Community Center and featured North Augusta, SC Mayor Lark Jones as our guest speaker. Mayor Jones gave a presentation titled "The Future of North Augusta, Planning and Managing for Success."

Located between Augusta, Georgia and Aiken, South Carolina, Mayor Lark Jones sees North Augusta as a city well positioned to handle the future. "We are unusual in North Augusta in that we don't boom and we don't bust. Just slow, smooth, steady growth. That's good because you can plan, you can do, and you can manage for growth."

With a projected population of 20,000 by the year 2010, North Augusta has strived to proactively deal with residential and commercial growth, growing traffic issues, increased public safety requirements, expansion of utilities and sewers, and the ability to attract and retain those amenities that the growing population seeks. With over 3,000 sites currently approved or in the approval process for future homes, North Augusta's future plans are designed to provide growth opportunities, yet maintain a "Mayberry" type setting.

The city of North Augusta is very sound financially, with reserves funds of over \$3M. Mayor Jones attributes this to very conservative forecasting for revenue and growth projections, and the ability of the city employees and council members to treat the city's money as if it were their own. Proactive planning for future change, scheduling, scope definition, tracking of costs, and conservative forecasting has positioned North Augusta in the building of a new municipal building and the Palmetto Parkway, both projected to complete by the summer of 2009, and the expansion of several recreational services throughout the area.

Inclosing, Major Jones stated that the city of North Augusta is well positioned to handle the future. "Most of it is not necessarily due to the mayor, but to the outstanding people that we have who work for the city and also our citizens who take great pride in our city and volunteer and do all the things that you really do need to do to make a community great."

David K. Foot, Professor of Economics at the University of Toronto, is co-author of the best-selling books Boom, Bust & Echo: How to Profit from the Coming

Demographic Shift and Boom, Bust & Echo: Profiting from the Demographic Shift in the 21st Century. These books reflect his research on the relationships between economics and demographics and on the resulting implications for both private and public policies.

As an outspoken and controversial demographics expert, Professor Foot can bring to life demographic statistics and make the aging of society relevant to any group. He contends that demographics explain two-thirds of everything. Change can't be avoided, but it can be anticipated and managed. With an understanding of demographics, a business, an individual or a government has a strong foundation upon which to build an understanding of the past and a vision for the future.

Speaker: Mr. Adesh Jain, M. Eng, CPP, MPD

Immediate Past President and current Chair of the Council of Delegates for the International Project Management Association (IPMA), will speak at the International Luncheon on Monday, June 30th.

Mr. Jain's career includes nearly 40 years of project-oriented work. In 1992, he started the Centre for Excellence in Project Management with a sole aim of strengthening project management in India and in the world. By 1995, his belief that general management is a subset of project management was well accepted.

Mr. Jain has addressed or trained over 50,000 people world wide. He has given more than 40 keynote presentations on varied topics of project management. He is author of the book "New Dimensions in Project Management" (1992) and over 50 articles. He is the originator of such breakthrough concepts as 'Project Mindset' and 'Project Thinking'. He has been invited to talk on Project Thinking at major International Conferences and Seminars, the first one in Stockholm, Sweden in August 1999.

In short, Mr. Jain is a legendary figure whose passion and dedication for strengthening project management is recognized worldwide. He is a visionary leader who has helped to shape the PM profession globally, who is known for his dedication and concern for the global community.
