## Jim LaClair Shaw Areva MOX Services LLC

It was a very interesting and informative presentation by Mr Jim LaClair in September. He presented a video of a very similar plant in France that has been performing the same processes that the MOX plant will perform here at SRS.

The MOX plant will cost about \$4.86 Billion and will cost about \$300 Million per year to operate. 34 metric tons of plutonium will be processed with another 9 metric tons identified for future processing. 3.5 metric tons of plutonium will be blended into MOX fuel annually. As of August, the MOX plant was 34% complete.





Catching up with Jim Gordon (talking to Terry McNew on the left) "Jim Gordon's nuclear career has spanned 26 years (1983 to present) working on various Start-up's throughout the United States. Jim changed from the Start-up Engineer to Project Controls Engineer discipline back in 1990 while at SRS. While at SRS he has worked with various groups, Construction with Tim Turner/Bruce Immonen, Start-up with Terry McNew, Environmental Restoration with Steve Morton/Ralph Kay/Ronny McIver and Operations with Joe Knick. Jim took early retirement with Bechtel back in 2005 and went to work for Shaw AREVA Mox Services as the Lead Startup/Operations Scheduler.

Jim left MOX in April of 2009 and started his own company, Morlite Consulting Services, LLC. Currently Jim's company is under contract with another firm and employed at the SRS as a DOE-HQ Consultant."
